Ms. Cunningham is delighted to represent the timeshare industry in the Regulatory Council of Community Association Managers and is looking forward to serving with excellence and distinction.

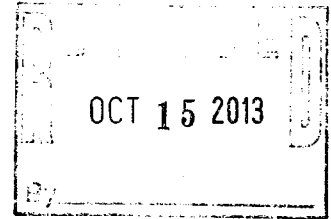
